#### **RESOLUTION PROPOSAL**

# ITEM 9 OF THE AGENDA FOR THE ANNUAL GENERAL SHAREHOLDERS MEETING OF APRIL 3<sup>RD</sup>, 2014

## Whereas:

- A) Under article 27(1) of the bylaws of REN Redes Energéticas Nacionais, S.G.P.S., S.A. (hereinafter "REN" or "Company"), the members of the governing bodies are elected for 3 year terms;
- B) The 2012-2014 term of office is ongoing;
- C) On the 6<sup>th</sup> of March, 2014, Mr. Emílio Rui Vilar, a member of the Audit Committee, presented his resignation to his respective position, to be effective under the applicable legal terms (i.e., at the end of the month following his resignation or upon his substitution, whichever occurs first);
- D) Following the resignations presented by Mr. Emílio Rui Vilar, the election of a new member of the Audit Committee to complete the current term of office replacing the resigning member is fully justified in the Company's best interest.

The election of Parpública - Participações Públicas (SGPS), S.A. - who appointed Prof. Aníbal Durães dos Santos to discharge functions in its own name - as member of the Audit Committee, to complete the ongoing 2012-2014 term of office, in replacement of Mr. Emílio Rui Vilar, is hereby proposed to the Shareholders of REN.

## PARPÚBLICA - PARTICIPAÇÕES PÚBLICAS (SGPS), S.A.

Parpública - Participações Públicas (SGPS), S.A. ("Parpública" or the "Company") is a public holding company, governed by the provisions of Decree Law no. 209/2009, of September 2, and is a policy instrument of the state, due to its dependency on the Ministry of Finance, designed to act on the following matters:

- a) The management of the public equity interests held by it;
- b) The management, through specialized subsidiaries, of the public real estate assets it holds;
- c) The rendering of technical support to the Minister of Finance on the financial oversight over state enterprises and concessionary companies which render services of a general economic interest, as well as to the management of the state's financial assets;
- d) The rendering of services relating to the liquidation of companies dissolved by the state or other public entities;
- e) The rendering of management and administration services to the companies in which it holds interests.

The Company adopts a model of management and audit which comprises a board of directors, with an audit committee and a certified accountant, which corresponds to an Anglo-Saxon governance system.

Parpública secures an effective control of some of the most important sectors in the Portuguese economy, holding majority shareholdings in various companies, notably, TAP - SGPS, S.A., INCM - Imprensa Nacional Casa da Moeda, S.A. or AdP - Águas de Portugal, S.A.

Parpública holds 52.871.340 shares representatives of 9,9% of the share capital of REN.
