CGC is the parent company of Capital Research and Management Company ("CRMC"). CRMC is a U.S.-based investment management company that manages the American Funds family of mutual funds. CRMC manages equity assets for various investment companies through three divisions, Capital Research Global Investors, Capital International Investors and Capital World Investors. CRMC in turn is the parent company of Capital Group International, Inc. ("CGI"), which in turn is the parent company of five investment management companies ("CGI management companies"): Capital Guardian Trust Company, Capital International, Inc., Capital International Limited, Capital International Sàrl and Capital International K.K. The CGI management companies primarily serve as investment managers to institutional clients.

Neither CGC nor any of its affiliates own shares for its own accounts. Rather, the shares reported are owned by funds and accounts under the discretionary investment management of one or more of the investment management companies described above.

SMALLCAP World Fund, Inc. ("SCWF") is a mutual fund registered in the United States under the Investment Company Act of 1940. SCWF is the legal owner of 20,085,000 shares (3.7612% of outstanding shares) and has granted proxy voting authority to CRMC, its investment adviser.

SCWF submitted a separate notification disclosing its holdings as of 3 May 2016.

- in the circumstances foreseen in letter (e) of Article 10 of that Directive, the controlling natural person or legal entity and, provided it has a notification duty at an individual level under Article 9, under letters (a) to (d) of Article 10 of that Directive or under a combination of any of those situations, the controlled undertaking;
